This website uses a cookie. Cookies are very small text files that are stored on your computer when you visit some websites. We use cookies to help identify your computer so we can tailor your user experience. You can disable any cookies already stored on your computer, but these may stop our website from functioning properly. The cookie for this website will remember user preferences such as your preferred country selection. No personally identifiable information is stored within the cookie.

### 2. Personal Information We Collect

#### Your Name, Address and Postcode:

We ask for your full name and address so that we can differentiate you from other customers and arrange certain services such as follow up visits from the Sales Director and to make deliveries.

#### Your E-mail Address:

This is used to send confirmation messages and other electronic correspondence to you.

#### **Your Telephone Number:**

We ask for your telephone number so that we may contact you quickly, should we need additional information pertaining to your order/enquiry with us.

#### **Your Mobile Number:**

Some customers prefer us to communicate to them via an SMS messaging service and social media platforms. You do not have to provide this but it gives us more flexibility in how we keep you informed.

# 3. How We Keep Your Data Safe

Your personal information is stored within a secure database. Access to this information is restricted to only those persons within the organisation that have a direct requirement to view that information. All computers and devices within CBS Architectural Ironmongery Ltd have AVG AniVirus protection software installed, and reside behind a high-grade firewall. Regular scans for anomalies are performed on the computers and devices.

## 4. Your Right To Access and Your Right To Be Forgotten

Under GDPR law, you have a right to request a copy of all personal information that we hold on you. Under GDPR law, you also have a right to be forgotten, which means the right to withdraw the consent for us to use your personal information, and the right to request to have all or part of the personal information removed from our systems and databases.

#### 5. Breach Notification

Under GDPR law, we are required to inform you of any data breach that "is likely to result in a risk for the rights and freedoms of individuals". This is required within 72 hours of us first becoming aware of such a breach. We take all reasonable measures to prevent a breach from occurring, however if a breach should occur we will tell you exactly how it happened and what personal data is likely to have been affected.
